- 1. With reference to the G.O. 1st cited the Committee was constituted for fixation of Fee in respect of Self Financing Colleges under the Chairmanship of Hon'ble Mr. Justice K. Venkataraman.
- 2. The Committee decided to fix the fee for the academic years 2020-2021, 2021 2022 and 2022-2023 for the U.G / P.G Dental Courses,
- 3. The Committee sent communication to the Secretary, Tamil Nadu Private Professional Colleges Association Health Science, Chennai requesting the Association inform to the member colleges of the Association to submit the fee proposal in the prescribed format to the Committee on or before 30.06.2020, Vide ref (2).
- **4.** Only 08 Dental Colleges have submitted the fee proposal for fixation of fee for the year 2020 -2021.

ORDER:

- 1. The Committee by an order dated 06.06.2017 fixed the following fees for the years 2017 -2018, 2018 -2019 and 2019 -2020 including Tuition fee, Admission fee, Special fee, Laboratory / Computer / Internet fee, Library fee, Sports fee, Maintenance and Amenities fee, extracurricular activities fee, and other recurring expenditure.
- 2. Considering the Pandemic of COVID -19, the Committee is of the view that the fee already fixed by the Committee is applicable for the year 2020 -2021 also.

3. Thus the fee fixed by the Committee for U.G / P.G Dental Courses are as under,

- 4. The maximum fee structure prescribed will take effect for the students admitted for the academic year 2020- 2021 only.
- 5. This fee is an all inclusive annual fee including various fees like admission fee,
 Tuition fee, Special fee, Laboratory / Computer / Maintenance and Amenities fee,
 Extracurricular activities fee and other recurring expenditure etc.,
- 6. In addition to the above fees, the institution is permitted to collect an amount of Rs.25, 000/- per student as development fee.
- 7. In addition to the above recurring annual fee, the concerned institutions are permitted to collect a refundable one time caution deposit not exceeding Rs.5000/- per student at the time of admission, to be refunded at the time of the student leaving the institution.

- 8. The management is directed to cover all the Students under Students Group Insurance Scheme.
- 9. The above fees does not include Hostel, Transport, Mess charges etc.,
- 10. The Committee directs that the institutions shall not charge either directly or indirectly any other amount over and above the amount fixed as fees. If any other amount is charged under any other head or guise e.g. donations, the same would amount to charging of capitation fee.
- 11. Any deviations of this order of this Committee will entail serious penal consequences like withdrawal of approval by MCI and disaffiliation by the concerned University as well as imposition of fine.
